LIABILITY WAIVER, RELEASE, ASSUMPTION OF RISK, AND EMERGENCY INFORMATION

The undersigned, a lawful parent or guardian of the child, hereby appoints Temecula Valley Fitness Club to be lawful attorney-in-fact (agent) to perform any and all acts that for the following purposes: To authorize any and all medical and hospital care and treatment including major surgery deemed necessary by the personnel of any medical facility or physician, for the health and well being of my child (ren). I give this authorization in advance of any care or treatment being required in order to provide authority for my attorney-in-fact to give specific consent to any and all care and treatment that might be necessary in my absence. Any fees associated with the treatment of medical care or transport are the responsibility of the undersign not Temecula Valley Fitness Club.

The undersigned hereby agrees to assume the risk of injury in its entirety regardless of the cause. You (Buyer, each member and all guests) agree that if you engage in any physical exercise or activity or use any Temecula Valley Fitness facility or any of its affiliates or related entities, you do so at your own risk of any and all injury and/or damage while engaging in any physical exercise equipment (mechanical or otherwise), the locker room, sidewalk, parking lot, adjoining parking lots, stairs, lobby area, or any equipment at Temecula Valley Fitness. Member agrees to assume the risk in his or her participation in any activity, class program, instruction, or Temecula Valley Fitness sponsored event. You agree that you are voluntarily participating in the aforementioned activities and using the Temecula Valley Fitness facilities and premises and assume all risk of injury, illness, damage, or loss to you or your property that might result from the negligence of Temecula Valley Fitness or any of its affiliates, employees, agents, representatives, successors, and assigns.

You agree on behalf of yourself (and all of your personal representative, heirs, executors, administrators, agents and assigns) to release and discharge Temecula Valley Fitness (and our affiliates, employees, agents, representatives, successors, and assigns) from any and all claims or causes of action (known and unknown) arising out of the negligence of Temecula Valley Fitness or any of its affiliates, employees, agents representatives, successors, and assigns. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your use of the exercise equipment or facilities that may malfunction or break, (b) Temecula Valley Fitness' improper maintenance of any exercise equipment or facilities, (c) Temecula Valley Fitness negligent instruction or supervision, including personal training and, (d) you slipping and falling while on or in the facility or any portion of the premises for any reason, including Temecula Valley Fitness negligent inspection or maintenance of its facility. By execution of this agreement, you hereby agree to identify and hold harmless Temecula Valley Fitness from any loss, liability, damage, or cost Temecula Valley Fitness may incur due to your presence at Temecula Valley Fitness facility. You further expressly agree that the foregoing release, waiver, and identity agreement is intended to be a broad and inclusive as permitted by the law and the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Member represents and warrants that member and responsibility are in good physical condition; that member or responsibility has nothing preventing them from engaging in active or passive exercise or from any activity or service offered by Temecula Valley Fitness.

YOU ACKNOWLEDGE THAT YOU HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY, AND EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. YOU ARE AWARE THAT BY EXECUTING THIS WAIVER YOU RELEASE TEMECULA VALLEY FITNESS, WHICH YOU HAVE ENROLLED YOUR CHILD(REN), AND ALL AFFILIATES, EMPLOYEES, AGENTS, REPRESENTATIVES, SUCCESSORS, AND ASSIGNS OF ANY LIABILITY FOR DAMAGES ARISING FROM ANY PERSONAL PROPERTY LOSS OR ANY INJURY RECEIVED BY ME OR ANY CHILD(REN) WHILE PARTICIPATING IN THE FACILITY SERVICES, EVENTS, CLASSES, PROGRAMS, CAMPS, AND/OR ACTIVITIES.
